1 Background

The SME Development Office (SMEDO) is an advisory body within the Ministry of Economic Development and Trade of Ukraine (MEDT) that provides technical assistance to the ministry and its 'Department for Entrepreneurship Development and Regulatory Policy' in implementation of Ukraine's SME Development Strategy 2020 and the associated SME Support Action Plan. The Action Plan's activities will focus on:

- Creating favourable environment for SME development;
- Improving SME access to finance;
- Simplify SME tax administration;
- Promoting entrepreneurial culture and develop entrepreneurial skills;
- Improving competitiveness and SME innovation potential.

During its initial phase, SMEDO will have 10 staff members in total, allocated to two units: one for 'SME and Entrepreneurship Promotion' and another for 'SME Policy Implementation'.

The SMEDO establishment is funded by the EU until March 2019 through its EU4Business project FORBIZ that supports the ministry with conceptual contributions, staffing and coaching.

2 Scope of Work

1) SME policy coordination and PPD:

- i) Provision of assistance to the MEDT in SME policy implementation and coordination with stakeholders;
- ii) Provision of assistance to MEDT on operations of SME policy coordination body;
- iii) Development of communication with key actors from private and civic sectors and support in creation of an effective PPD;
- iv) Collecting relevant data and stakeholders inputs on SME policy and PPD implementation, including coordination body sessions organisations and secretariat activities;
- v) Coordination with representatives of the EU and international organisations and monitors the implementation of SBA principles and other international directives relevant to SME development;
- vi) Coordination and cooperation activities and monitors procedures and timeframes for implementation of DCFTA projects.

2) SME policy monitoring:

- i) Participation in creation and implementation of SME strategy and Action plan monitoring and evaluation tools;
- ii) Collection, processing and analysis of relevant statistic and other data related to SME sector development;
- iii) Preparation of annual and periodic reports on SMEs;
- iv) Provision and assistance to MEDT on preparation of analytical documentation for SME policy coordination body;
- v) Manage and collection of data for annual SME survey;
- vi) Processing statistic data, prepare benchmarks and reports on MEDT demands;
- vii) Analysis and reporting on the impact made from implementation of other policies and measures relevant for the SME sector development;
- viii) Analysis of the business trends and economic outlooks.
