Background

The Professionals for Reform Support Mechanism (PRSM) provides human resource support – from managers to technical experts - to critical reform initiatives undertaken by national governmental agencies. PRSM is a multi-donor platform, which improves coordination of donor efforts for greater impact and avoids overlap of donor funding. It does not support routine work of the Government of Ukraine that is normally managed by the civil service. To do this, PRSM:

- Selects initiatives based on clearly defined links to reform initiatives;
- Ensures transparent recruitment of human resources;
- Manages the contracting and payment of human resources;
- Provides financial reports for donors;
- Monitors initiatives for results.

Reform Initiative

The Ministry of Economic Development and Trade of Ukraine is implementing the reform of the technical regulation system of Ukraine. The reform is aimed to secure consumer safety along with implementation of commitments under the Association agreement between Ukraine and the European Union.

Consumers Rights Protection System reform is aimed to enhance institutional ability of the government to enforce legislation on product safety and to solve problems hindering reformation and proper functioning of the state market surveillance and consumer rights protection systems in Ukraine. The project will deliver a set of implementable solutions to be used by beneficiary ministry and other responsible stakeholders for accomplishing targeted reforms.

Position Summary:

Junior PR & Communication Expert will provide assistance in communication activities of the team, ensuring appropriate media coverage and public advocacy of the market surveillance and consumer right protection reforms, as well as assistance in coordination of communication messages with the Communications Team of the beneficiary Ministry.

Preferred Qualifications and Skills:

- Degree in Communications, Public Relations, Marketing or other education with relevant practical experience.
- General understanding of the technical regulation, market surveillance and consumer right protection reforms.

- Proven knowledge and expertise in communications.
- Strong skills in written communication.
- Strong skills in production of visual aid support materials (infographics, presentations).
- Graphic design skills (presentations, infographics, brochures, posters PowerPoint, Adobe Photoshop, Adobe In-Design).
- Strong public speaking and presentation skills.

- Professional knowledge of Ukrainian with superior ability to write and proofread press releases, columns and other communications materials.
- Ability to formulate strong but simple messages related to the reforms.
- Ability to work with social networks.
- Experience in communications, public relations, media, consulting.

- Experience in international organizations, reform projects at the governmental level will be an advantage.
- Experience in media crisis management will be an advantage.

Indicative duties and responsibilities:

- Providing proper communication support to the market surveillance and consumer right protection reforms.
- Assistance in development of information materials, media publications.
- Assistance in organization of events dedicated to awareness-raising on Rapid alert system on dangerous products and e-tools to be developed by the team.
- Assistance in identifying ways to engage stakeholders.
- Assistance in development, customization and proofreading of project materials.
- Assistance to the beneficiary Ministry in organization of a Consumer rights protection forum and other public events.
- PR advisory in communication with business associations and NGO.
